

## **Privacy Statement**

The following statement discloses our information gathering and dissemination practices for this website: MosquitoManagers Biting Insect Traps. ([www.mosquitomanagers.com.au](http://www.mosquitomanagers.com.au))

This document was last updated in April 2008.

At MosquitoManagers, we are committed to protecting your privacy and supplying equipment that gives you the most effective protection against mosquitoes and other biting insects. You can browse through our site without giving us any information about yourself but, sometimes we do need information to provide services that you request, and this statement of privacy explains data collection and use in those situations.

### **Collecting your Personal Information.**

We will ask you when we need information that personally identifies you (personal information), or allows us to contact you. Generally, this information is requested when you are ordering or enquiring for more information on one of our products. If you choose a product that requires payment, such as making a purchase for one of our units, we will request personal information necessary for billing and/or shipping, such as: name, address, telephone number, and credit card number. When you buy a new product, we will ask you to register your purchase electronically. When you do, we keep this registration information on file with any information you've already given us on previous visits to our Web site. This is considered your personal profile. You do not have to purchase online and have an option to order through facsimile or by Electronic Funds Transfer (EFT).

### **Use of your Personal Information.**

We use your personal information for the following purposes: To make the site easier for you to use by not making you enter your personal information more than once. To deliver services or products that you request or purchase. To help you quickly find products or information on MosquitoManagers.com.au. To help us create and publish content most relevant to you. To alert you to product upgrades, special offers, updated information and other new services from MosquitoManagers.com.au. We occasionally hire other

companies to provide limited services on our behalf, including packaging, mailing and delivering purchases. We will only provide those companies the information they need to deliver the service, and they are prohibited from using that information for any other purpose. MosquitoManagers may disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on MosquitoManagers or the site; (b) protect and defend the rights or property of MosquitoManagers, or (c) act in urgent circumstances to protect the personal safety of users of MosquitoManagers, its Web sites, or the public. Your information may be stored and processed in Australia.

### **Control of your Personal Information.**

When you register, or otherwise give us personal information, MosquitoManagers will not share that information with third parties without your permission, other than for the limited exceptions already listed. It will only be used for the purposes stated above. MosquitoManagers may send out periodic e-mails informing you of technical service issues related to a product or service you requested.

### **Access to your Personal Information.**

You may review and update this information at any time by requesting the information through the site or facsimile. You can: View and edit personal information you have already given us. Tell us whether you want MosquitoManagers to send you marketing information. Subscribe, or cancel subscriptions, to newsletters about our services and products.

### **Security of your Personal Information.**

MosquitoManagers strictly protects the security of your personal information and honors your choices for its intended use. We carefully protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction. Your personal information is never shared outside the company without your permission, except under conditions explained above. Inside the company, data is stored in password-controlled servers with limited access. You also have a significant role in protecting your information so do not share these with others.
